## **WHAT'S NEW?**

The most significant event coming up (including who won the other election, the results not known at the time of writing) is our **Annual General Meeting**, to be held at 7 pm on Tuesday 24 August in the Conference Room. At this meeting, you, the members, will elect the Management Committee for 2010-11. In fact, the Committee has already been elected, since the nominations received by the due date were sufficient to fill all the positions. By the Constitution, all nominees are thereby automatically appointed to the respective positions. For your information, there will be no change in the names or positions on the Committee, which will consist of Clive Rattlidge (President), Don Turner (Vice-President), Kevin Poschalk (Secretary), Jeff Stickley (Treasurer), and Committee Members Bob Bowd, Jennifer Gimm, Jock Slack-Smith, Wally Watkins and Sue Zanker. Regrettably, for a number of reasons, Laurie Wickham was forced to withdraw his nomination. In spite of this, the Committee's numbers are complete. The Club should be very grateful to these people for continuing to volunteer their time and energy for the benefit of the Club.

The business part of the AGM should not take very long at all, but there are certain formalities to be taken care of. The most important is to vote on a Notice of Motion received by the appointed date, 3 August 2010. This motion, moved by K.A.Poschalk, seconded C.Rattlidge reads:

That the Club purchase a laptop computer with operating system Windows 7, to include Office 2010 programs and necessary accessory programs, to the value of \$1698 as per the attached quote from Computer Bits & Bytes.

Some of the rationale for the purchase of this equipment was given in the July Newsletter, but the motion will be presented and spoken to, for and against, in the approved manner - one speaker For, one Against etc until argument is exhausted.
